April 21 - 22, 2012 ☞ **Saturday & Sunday, 10:00 am - 5:00 pm**

The Emerging Artist Program is designed specifically for exceptional artists who have **never exhibited or sold their work at an outdoor festival**. Artists who are just beginning their careers are encouraged to apply. The Festival Committee reserves the sole right to determine if applicant qualifies for this program.

Artists chosen to participate in the Emerging Artist Program will have the opportunity to exhibit and sell their work, meet other renowned artists, and participate in a nationally recognized festival. Each artist is provided with a 10'x10' space at a significantly discounted cost of \$50.00. Emerging Artists are not eligible to be juried.

The booth fee includes the following benefits:

- Listing in Festival Magazine
- Saturday evening Artist Awards Dinner Invitation for you and a guest
- Up to 25 PosterCards available for pre-show promotion (pickup at LeMoyne)
