



2017 Corporate Vendor Application Festival Information & Guidelines

April 15 & 16 ↻ **Saturday 10am – 7pm & Sunday, 10am – 5pm**

Join us for the 17th annual LeMoyne Chain of Parks Art Festival. Be in front of more than 50,000 visitors at our two-day festival featuring fine art and local cultural experiences, gourmet foods, and live entertainment on the streets and the chain of parks in beautiful downtown Tallahassee, Florida.

- Booth space is limited. Applications will be accepted for review until **February 24, 2017**. If space is available late applications will be considered with a \$25.00 late fee. Please note: acceptance of an application is not acceptance into the Festival.
- Applications will be reviewed for acceptance and notification of acceptance will be given via email and notifications of non-acceptance will be given via email/phone.
- Booth payment must be paid in full and included with this application. Payments will be refunded in full if the application is not accepted. A \$25.00 NSF (Non-sufficient funds) fee will be assessed for any returned checks.
- Booth cancellations are non-refundable after March 15, 2017. A \$50.00 administrative fee will be charged for cancellations prior to March 15, 2017. Refunds will be given within 30 days.
- Vendor fees will not be refunded if the festival must be cancelled due to inclement weather, acts of God, or any other circumstance deemed necessary by LeMoyne Chain of Parks Art Festival and city officials.
- Booth spaces are 10' x 10'. All booths are outdoors in The Village and are assigned based on vendor category.
- Booth set up begins at 5:30 pm on April 14, 2017. Booths must be set up by 8:30 am on April 15 and disassembled by 6:00 pm on April 16.
- All vehicles must be moved to designated parking by 8:00 pm on Friday, April 14 or they will be subject to towing from festival grounds.
- Chain of Parks Art Festival is held outdoors on city streets and in parks. Electricity is available for purchase for \$25.00 per plug (20 AMPS).
- An email indicating acceptance in the Festival will be sent out in March. Additional booth information, maps, permits, rules and regulations will be emailed in March.
- Vendors supply their own booth tables, chairs and small tents (no larger than 10x10).
- Vendor tents must be properly weighted down; stakes are not permitted.
- Payment can be made by check, money order, or credit card (Visa, Master Card accepted). Make checks and money orders payable to LeMoyne Chain of Parks Art Festival.
- All vendors must return a signed General Release Form with application including one witness signature (does not have to be notarized).
